## (Rich/Derek) Freestyle Pricing

I'm asking for a revision to the month-to-month All You Can Skate pricing for freestyle. During my discussion with DMFSC Directors, they asked if we would be willing to extend it to Associate Members. The coaches in attendance felt that they could get several of their students on board with it, and I'm personally willing to give it a shot to help bring in predictable revenue for freestyle.

Motion: Extend month-to-month pricing for All You Can Skate for 2019-20 season to Associate Members.

Motion was adopted.

After review of our membership price levels, and discussions with the coaches, I feel that our pricing for LTS USA Membership vs. CIFSC Membership and Associate Membership is not one that is going to be workable for the club. With LTS USA giving nearly all the same benefits as a membership or associate membership, associates considering joining would be better off purchasing a duplicate membership through LTS USA and not even considering the associate membership. People interested in gaining access to freestyle would, again, be better off joining LTS USA vs. using our introductory membership. I'm asking that the Board reconsider this decision.

Motion: to require solo performers to be members or associate members of the Club. Options will be provided for LTS USA members to participate in a group number at a reasonable price.

Motion was adopted unanimously.

## (Rich) Compensation for Fundraising

Motion: End compensation for fundraising by Directors and members.

Iowa Code requires that people who receive compensation for soliciting funds for a charitable organization to register as a professional fundraiser. A commission paid, even as a credit for club services, is compensation.

While it has been approved in the past, it is my opinion that we need to end this practice in order to comply with Iowa Code and not accidently cause a member to be classified as a professional fundraiser.
